In 1995, he expanded into the catering sector, serving over 5,000 employees.

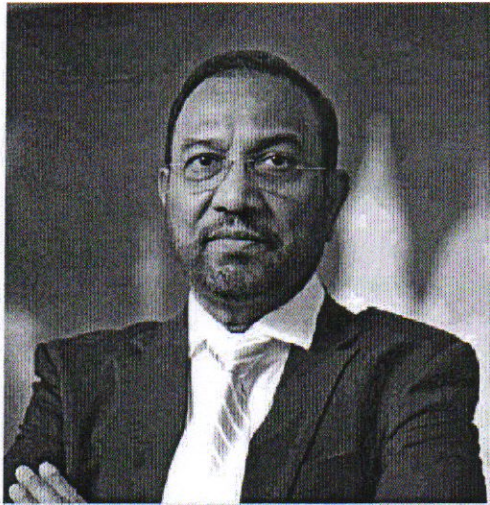
